<u>Canberra Seniors Centre replacement</u> – Peter Johns and Clare Wall (CSD); Sean Hogan (Colin Stewart Architects.

The Community Services Directorate (CSD) is conducting a feasibility study for the replacement of the Canberra Seniors Centre at Turner.

The Centre currently has 400 members and has 200 sq m premises in Turner.

<u>Redevelopment of Construction House 271 Northbourne Avenue</u> – Peter Byfield of Peter Byfield + Associates pty ltd.

The proposal is to build 100 apartments above the existing 4,000 sq m of commercial office space on the site, plus nine 3-storey terrace houses alongside Forbes St.

Local residents expressed concern about soundproofing and energy efficiency of the residences, and about the additional traffic that they will generate on Forbes St.

Mr Byfield advised that they will have an opportunity to comment when the Development Application is formally lodged.
