#### **GUEST PRESENTATION/S**

# Proposed redevelopment of the Lyneham Motor Inn (39 Mouat St Lyneham)

Rebecca Stockley, of Knight Frank Town Planning, explained that the Lyneham Motor Inn is currently zoned <u>CZ6 Leisure and Accommodation</u>. A Territory Plan variation will be required if it is to be redeveloped for residential, office, general administration or home business purposes. Knight Frank will continue to consult with the Community Council as the project develops.
