The Dickson tram stop is to be just north of Murdoch St, near the bus interchange between Northbourne Avenue and Challis Street and immediately south of the Motor Registry. The Light Rail contract is due to be signed in the second quarter of 2016, prior to the 15 October 2016 ACT election.
