The presentation and Q&A session covered a range of topics including:

- members' questions on travel times, seating, changing transport modes for one trip, traffic impacts, and future No 39 bus operations, that had been forwarded to Ms Thomas prior to the meeting
- integration of buses, light rail and taxis;
- the Government's commitment to 10.5% of journeys to work by public transport by 2016;
- flexible bus services;
- a bus trip even to an adjacent suburb may require a change of buses;
- the cost of the light rail contract that was signed earlier on the day.
