## **GENERAL BUSINESS**

## 1. Discussion of Northbourne Ave developments

#### 3. Chair's Report

Discussion of Committee positions. Options of rolling positions taken up by residents associations. Need for succession planning. A regular turnover of positions such as Chair, Deputy Chair and Secretary. Opportunity to volunteer for positions or deputy for roles as a precursor to doing the role the following year. Committee members to canvas their associations. Point made that some associations are struggling to maintain their own committees.

- Thanks to Bruce for maintaining financial records and meeting obligations sufficiently to be scrutinised.
- Chair to meet with David Pocock. He is proposing a significant planning vision for Canberra, some which is cutting across the recent planning discussions. Interested in freeing up land for housing.
- Discussion on benefits and disbenefits of **rezoning**, including the impacts on affordability, ability to deliver supply, land valuation and rates, lease variation charges (LVC).
- The importance of design rules. Considering the proposed millions of dollars to be spent by the Commonwealth Government on housing that as well as demanding planning changes to encourage greater density there needs to be appropriate design rules in place to ensure that the housing is affordable, climate resilient and carbon neutral.

## 4. Treasurer's report

Associations asked to put in their funding proposals to finalise budget. The current balance of the NCCC account is \$5,294.

#### 5. Other business

Update on the ACT Government's *Growing and Renewing Public Housing Program* that saw hundreds of public housing tenants receive a letter threatening them with forced relocation. Both Minister Berry and Minister Vassarotti have apologised to public housing tenants for poor processes undertaken during the implementation of this program and hopes that Housing ACT will do better in the future. This was in response to a damning report by the ACT Ombudsman.
